IMPACTED CLIENTS

WHICH COMPANIES REQUIRE CERTIFICATION?

The Australian Government has agreed to participate in the exchange of information with other jurisdictions under the Foreign Account Tax Compliance Act (**FATCA**) and Common Reporting Standard for Automatic Exchange of Financial Account Information (**CRS**). Financial Institutions are now required to undertake due diligence to determine shareholders' tax residence jurisdictions.

A number of Computershare's clients are impacted by FATCA and CRS and we are assisting these clients to comply by collecting their shareholders' tax residence jurisdictions through self-certification and in some cases reporting this information to the Australian Taxation Office (**ATO**), which will pass on this information to the relevant jurisdictions authorities.
