## Small Estate Indemnity

This form replaces our requirement for Australian Probate or reseat of Foreign Probate, where permitted under Australian law, when the current market value of the securityholding does not exceed AUD\$50,000. If the deceased did not leave a valid Will an 'Intestacy Request and Indemnity' form must be completed instead.
