Section 1071B Statement

This form is used where Australian Probate/Australian Letters of Administration or reseal of Foreign Probate/Foreign Letters of Administration has/have been granted in an Australian State other than where the securities are registered. A statement in writing as prescribed by Section 1071B of the Corporations Act must be lodged, together with a transfer/transmission within three months of the statement being made.

The Corporations Act imposes severe penalties for making a false statement (\$10,000 or 2 years imprisonment or both) or failing to ensure a statement is not false or misleading (\$5,000 or 1 year imprisonment or both).

For each company in which the deceased has a securityholding a separate form must be submitted.
